

The Expedited Course Revision proposal is used to request updates to an existing course listed in Banner after the Curriculog deadline has passed. This proposal is limited to users who have obtained approval from the Associate Vice President for Curriculum & Instructional Innovation prior to submitting.

# INSTRUCTIONS COMPLETING THE PROPOSAL

- 1. Gain permission from the Associate Vice President for Curriculum & Instructional Innovation to submit this proposal after the Curriculog deadline. Proposals that have not received prior approval will not be approved by the Curriculum Systems Manager.
- 2. Login to Curriculog using your net ID and password. https://augusta.curriculog.com
- 3. Select "New Proposal" from the task menu.

### **IMPORTING**

5. Once the expedited course revision proposal is selected, navigate to the top of the proposal, and select Import. It is important to import the current course information from the catalog prior to editing the proposal.

7. Once you have selected the external system to import from, a filter box will appear. In the filter by field drop down, select **Prefix**. This will allow you to search for all courses with that prefix to find the correct course to import.


